## Did you know?

Space heaters are responsible for 32 percent of house fires, according to the National Fire Protection Association. If you must use space heaters, operate them safely.

- Place your space heater on a level, non-flammable surface.
- Make sure your space heater has an auto shutoff function.
- Plug your space heater directly into the outlet-not an extension cord or power strip.
- Keep your space heater at least 3 feet away for anything flammable.
- Never leave your space heater unattended.

Space heaters can also increase your electric bill significantly. Do you use a space heater to heat a room or small section of your home?

 For example, you have a 1500-watt electric space heater to warm your living room while you watch TV or read a book. Operating that space heater for a couple hours a day will cost you about \$12 a month. Operating that same space heater for 12 hours a day will cost you about \$73 a month extra.


Redwood Electric's interruptible water heater program provides members with a Marathon water heater at half the price!
